Arrangements were made to receive hard copy of the answer scripts in the College and adequate time was given to ensure hassle free submission.

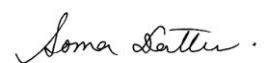
The problem regarding question paper download was fixed by the website maintenance committee soon after receiving the complaints.

Few computers have been procured by the college and some more computers will be coming in near future.


Overhead projectors are being used presently to facilitate efficient teaching in the class. Arrangements are underway to build properly equipped smart classrooms as soon as possible.

The issue of canteen has been discussed with the canteen committee.


Building committee has been asked to take up the issue of building ramps at various places in the college campus on urgent basis.
