Administration:

- We have usedGoogle Workspaceservice for taking classes, conducting meeting and other day to day jobs (due to lockdown, campus was closed most of the days) via Google meet service where recording facility is available.
- In addition to that the website of the college served us a lot where we have given class materials, recorded video links etc for the students.
- Departments uses different google platforms and WhatsApp group to keep smooth contacts with students.





Students' Admission and Support:

- Admission of students is conducted in fully online mode. Software related to student administration and support is maintained by a vendor named Rupantar.
- The students are required to fill and submit their admission forms in online mode and all relevant financial transactions for the admission process are carried out through the banking system.
- For disbursement of student scholarships every year, the college accesses and utilises information on the online portal of the Government of West Bengal.
- The college Library maintains an APP (Kandi Raj College Library), maintained by Librarianfor all library facility which has been used remotely by the students and staffs in this Covid situation when no one can enter into the campus.
- The college utilises a custom-built software(maintained by Rupantar), to maintain a database for student records and other student related information.

Examination:

- All the examinations are being conducted through portal (<u>https://kandirajcollegeonline.org/</u>), where students get their questions, upload answer scripts, teachers can view and examine those scripts.
- University also maintain a portal for marks uploading, publications of examination result etc. which are displayed in College Website.
- All notices relating to examinations are put up on the official website of the college and in different WhatsApp group and group mail.
